7	manner and procedure, insofar as are applicable thereto, as provided in Acts

9	(e) Any person who is a qualified elector of the State of Arkansas and
10	who is a resident and registered voter of the county, municipality, ward,
11	precinct, or other defined area in which a local option election is being

13	203 and 3-8-205 — 3-8-209, may sign the local option petition in his or her

15	(f) A person shall be guilty of a Class A misdemeanor if that person:
16	(1) Signs any name other than his or her own to any petition;
17	(2) Knowingly signs his or her name more than once to any
18	petition;
19	(3) Knowingly signs a petition when he or she is not legally
20	entitled to sign a petition;
21	(4) Knowingly and falsely misrepresents the purpose and effect
22	of the petition for the purpose of causing anyone to sign the petition.
23	(5) Acting in the capacity of canvasser, knowingly makes a false
24	statement on a petition verification form; or
25	(6) Acting in the capacity of a notary, knowingly fails to
26	witness a canvasser's affidavit either by witnessing the signing of the
27	instrument and personally knowing the signer or being presented with proof of
28	identity of the signer.
29	(g)(1) The provisions of this section are intended to be supplemental
30	to Initiated Act No. 1 of 1942, §§ 3-8-201 - 3-8-203 and 3-8-205 - 3-8-209,
31	and to establish reasonable and necessary provisions for providing safeguards
32	in the form of petitions and the circulation thereof and to prohibit
33	unauthorized persons from signing the petitions.
34	(2) Therefore, the provisions of this section shall be deemed to

Arkansas Code § 3-8-205, concerning sufficiency of 2 3 petitions in local option elections, is amended to add an additional 4 subdivision to read as follows: (f) Except as provided in this section, a petition for local option 5 6 election shall be governed by § 7-9-101 et seq. and § 3-8-701 et seq. 7 8 SECTION 3. Arkansas Code § 3-8-302 is repealed. 9 3-8-302. Petition and order for election. 10 (a) Upon application by written petition, signed by a number of legal voters in any county, city, town, district, or precinct to be affected equal 11 12 to thirty-five percent (35%) of the qualified voters, it shall be the duty of 13 the judge of the county court in the county at the next regular term thereof, 14 after receiving the petitions, to make an order on his or her order book 15 directing an election to be held in the county, city, town, district, or precinct to be affected thereby, on some day named in the petition no earlier 16 17 than sixty (60) days after the application is lodged with the judge of the 18 court. However, in counties having two (2) judicial districts, the legal 19 voters in either district may petition for an election and the election can 20 only affect the judicial district where the election may be held. (b) The order shall direct the sheriff or other officer of the county, 21 22 who may be appointed to hold the election, to open a poll at each and all of 23 the voting places in the county, city, town, district, or precinct on the appointed date, for the purpose of taking the sense of the legal voters of 24 25 the county, city, town, district, or precinct, who are qualified to vote at 26 elections for county officers, upon the proposition whether or not 27 spirituous, vinous, or malt liquors shall be sold, bartered, or loaned 28 therein. 29 30 SECTION 4. Notice and conduct of election. 31 32 (a) It shall be the duty of the county clerk to give the sheriff of 33 the county, or the officer as may be appointed to hold the election, a 34 certified copy of the order of the county court as it appears on the order book within five (5) days after the order is made. 35

(b) It shall be the duty of the sheriff or other officer to have the

1	order published in some weekly or daily paper published in the county for at
2	least two (2) weeks before the election and also to advertise the order by
3	printed or written handbills posted at some conspicuous place in each

30	SECTION 7. Arkansas Code Title 3, Chapter 8, is amended to add an
31	additional subchapter to read as follows:
32	Subchapter 6 - Disclosure Act for Initiative Proceedings
33	
34	3-8-601. Title.
35	This subchapter shall be known and may be cited as the "Disclosure Act
36	for Initiative Proceedings"

2	3-8-602. Definitions.
3	As used in this subchapter:
4	(1)(A) "Contribution" means, whether direct or indirect,
5	advances, deposits, transfers of funds, contracts, or obligations, whether or
6	not legally enforceable, payments, gifts, subscriptions, assessments,
7	payments for services, dues, advancements, forbearance, loans, pledges, or
8	promises of money or anything of value, whether or not legally enforceable,
9	to a person for the purpose of expressly advocating the qualification,
10	disqualification, passage, or defeat of a local-option ballot question.
11	(B) "Contribution" includes the purchase of tickets for
12	events such as dinners, luncheons, rallies, and similar fundraising events
13	and the granting of discounts or rebates by television and radio stations and
14	newspapers not extended on an equal basis to all persons for the purpose of
15	expressly advocating the qualification, disqualification, passage, or defeat
16	of a local-option ballot question.
17	(C) "Contribution" does not include:
18	(i) Noncompensated, nonreimbursed volunteer personal
19	services or travel;
20	(ii) Activities designed solely to encourage
21	individuals to vote or to register to vote; or
22	(iii) Any communication by a bona fide church or
23	religious denomination to its own members or adherents for the sole purpose
24	of protecting the right to practice the religious tenets of the church or
25	religious denomination;
26	(2) "Disqualification of a local-option ballot question" means
27	any action or process, legal or otherwise, that seeks to prevent a local-
28	option ballot question from being on the ballot at an election;
29	(3)(A) "Expenditure" means a purchase, payment, distribution,
30	gift, loan, or advance of money or anything of value, and a contract,
31	promise, or agreement to make an expenditure for goods, services, materials,
32	or facilities for the purpose of expressly advocating the qualification,
33	disqualification, passage, or defeat of a local-option ballot question.
34	(B) "Expenditure" does not include an expenditure made for
35	communication by a person strictly with the person's paid members or
36	shareholders;

1	(4) "Local-option ballot question" means a question in the form
2	of a local-option initiative that is submitted or intended to be submitted to
3	a popular vote at an election, whether or not it qualifies for the ballot;
4	(5)(A) "Local-option ballot question committee" means any
5	person, located within or outside Arkansas, that receives contributions for
6	the purpose of expressly advocating the qualification, disqualification,
7	passage, or defeat of a local-option ballot question or any person, other
8	than a public servant, a governmental body expending public funds, or an
9	individual, located within or outside Arkansas, that makes expenditures for
10	the purpose of expressly advocating the qualification, disqualification,
11	passage, or defeat of a local-option ballot question.
12	(B) A person other than an individual or an approved
13	political action committee as defined in § 7-6-201, located within or outside
14	Arkansas, also qualifies as a local-option ballot question committee if two
15	percent (2%) or more of the committee's annual revenues, operating expenses,
16	or funds are used to make a contribution or contributions to another ballot
17	question committee and if the contribution or contributions exceed ten
18	thousand dollars (\$10,000) in value;
19	(6)(A) "Person" means any individual, business, proprietorship,
20	firm, partnership, joint venture, syndicate, business trust, labor
21	organization, company, corporation, association, committee, or any other
22	organization or group of persons acting in concert.
23	(B) "Person" includes a public servant or governmental
24	body using public funds to expressly advocate the qualification,
25	disqualification, passage, or defeat of a local-option ballot question; and
26	(7) "Qualification of a local-option ballot question" means any
27	action or process, legal or otherwise, through which a local-option ballot
28	question obtains certification to be on the ballot at an election.
29	
30	3-8-603. Filing deadlines.
31	(a)(l)(A) A local-option ballot question committee shall file a Ballot
32	Question Committee Statement of Organization with the Arkansas Ethics
33	Commission within five (5) days of receiving contributions or making
34	expenditures in excess of five hundred dollars (\$500) for the purpose of
35	expressly advocating the qualification, passage, or defeat of a local-option
36	ballot question.

T	(b) The commission shall maintain the statement of
2	organization until notified of the committee's dissolution.
3	(2) A local-option ballot question committee failing to file a
4	statement of organization required by this section shall be subject to a late
5	filing fee not to exceed fifty dollars (\$50.00) for each day the statement
6	remains not filed.
7	(b) The statement of organization shall include the information
8	required by the statement of organization form prescribed by the director of
9	the commission, and any further information the director may by regulation
10	require.
11	(c) Rules regarding dissolution shall be governed by the rule of the
12	commission.
13	
14	3-8-604. Contributions and expenditures limited.
15	(a) No local-option ballot question committee shall accept any
16	contribution in cash, meaning currency or coin, that exceeds one hundred
17	<u>dollars (\$100).</u>
18	(b) No local-option ballot question committee shall accept any
19	contribution from a prohibited political action committee as defined in § 7-
20	<u>6-201.</u>
21	(c) No local-option ballot question committee or individual shall make
22	an expenditure in cash that exceeds fifty dollars (\$50.00) to influence the
23	qualification, disqualification, passage, or defeat of a local-option ballot
24	question.
25	(d) No contributions shall be made, directly or indirectly, by any
26	person in a name other than the name by which the person is identified for
27	<u>legal purposes.</u>
28	(e)(1) No person shall make an anonymous contribution totaling fifty
29	dollars (\$50.00) or more to a local-option ballot question committee.
30	(2) Any anonymous contribution actually received by a local-
31	option ballot question committee shall be promptly paid by the recipient to
32	the Secretary of State for deposit into the State Treasury as general
33	revenues.
34	
35	3-8-605. Financial reports — Requirement.
36	(a) A local-option ballot question committee that either receives

1	contributions or makes expenditures in excess of five hundred dollars (\$500)
2	for the purpose of expressly advocating the qualification, disqualification,
3	passage, or defeat of a local-option ballot question shall file with the
4	Arkansas Ethics Commission a Ballot Question Committee Financial Report as
5	required by §§ 7-9-407 - 7-9-409.
6	(b) A public servant or governmental body expending public funds in
7	excess of five hundred dollars (\$500) for the purpose of expressly advocating
8	the qualification, disqualification, passage, or defeat of a local-option
9	ballot question shall file with the commission financial reports as required
10	by §§ 7-9-407 — 7-9-409.
11	(c) Except as provided in subsection (f) of this section, a report
12	required by this subchapter shall be deemed timely filed if it is:
13	(1) Hand-delivered to the commission on or before the date due;
14	(2) Mailed to the commission, properly addressed, postage
15	prepaid, bearing a postmark indicating that it was received by the post
16	office or common carrier on or before the date due;
17	(3) Received via facsimile by the commission on or before the
18	date due, provided that the original is received by the commission within ten
19	(10) days of the transmission; or
20	(4) Received by the commission in a readable electronic format
21	that is approved by the commission.
22	(d) Whenever a report under this subchapter becomes due on a day that
23	is a Saturday, Sunday, or legal holiday, the report shall be due the next day
24	that is not a Saturday, Sunday, or legal holiday.
25	(e) A preelection report is timely filed if it is received by the
26	commission no later than seven (7) days prior to the election for which it is
27	<u>filed.</u>
28	
29	3-8-606. Financial report — Information.
30	In addition to the information required under § $7-9-407 - 7-9-409$ , a
31	financial report of a local-option ballot question committee shall contain
32	the following information:
33	(1) The name, address, and telephone number of the committee
34	filing the report;
35	(2) For a local-option ballot question committee:
36	(A) The total amount of contributions received during the

1	period covered by the financial report;
2	(B) The total amount of expenditures made by the committee
3	or on behalf of the committee by an advertising agency, public relations
4	firm, or political consultant during the period covered by the financial
5	report;
6	(C) The cumulative amount of contributions and
7	expenditures reported under subdivision (2)(A) of this section for each
8	local-option ballot question committee;
9	(D) The balance of cash and cash equivalents on hand at
10	the beginning and the end of the period covered by the financial report;
11	(E) The total amount of contributions received during the
12	period covered by the financial report from persons who contributed less than
13	fifty dollars (\$50.00) and the cumulative amount of that total for each
14	local-option ballot question committee;
15	(F) The total amount of contributions received during the
16	period covered by the financial report from persons who contributed fifty
17	dollars (\$50.00) or more and the cumulative amount of that total for each
18	<u>local-option</u> ballot question committee;
19	(G) The name and street address of each person who
20	contributed fifty dollars (\$50.00) or more during the period covered by the
21	financial report, together with the amount contributed, the date of receipt,
22	and the cumulative amount contributed by that person for each local-option
23	ballot question committee;
24	(H) For each person listed under subdivision (2)(A) of
25	this section, the contributor's principal place of business, employer,
26	occupation, the amount contributed, the date the contribution was accepted by
27	the local-option ballot question committee, and the cumulative amount
28	contributed for each local-option ballot question;
29	(I) The name and address of each person who contributed a
30	nonmoney item, together with a description of the item, the date of receipt,
31	and the value, not including volunteer service by individuals;
32	(J) A list of all paid canvassers, officers, and directors
33	and the amount each person was paid;
34	(K) A list of all expenditures by category, including
35	without limitation the following:
36	(i) Advertising:

2	(iii) Office supplies;
3	(iv) Travel;
4	(v) Expenses; and
5	(vi) Telephone; and
6	(L) The total amount of nonitemized expenditures made
7	during the period covered by the financial report; and
8	(3) The name and street address of each person to whom
9	reimbursement for expenditures totaling one hundred dollars (\$100) or more
10	was made, together with the date and amount of each separate reimbursement to
11	each person during the period covered by the financial report and the purpose
12	of each expenditure.
13	
14	3-8-607. Financial reports — Verification.
15	The financial reports identified in § 3-8-606 shall be verified by
16	affidavit by the person filing them to the effect that to the best of his or
17	her knowledge and belief the information disclosed is a complete, true, and
18	accurate financial statement of contributions or expenditures.
19	
20	3-8-608. Financial reports - Time to file - Late fee.
21	(a)(1) The first financial reports shall be filed no later than
22	fifteen (15) days following the month in which the threshold of five hundred
23	dollars (\$500) under § 3-8-606 is met and thereafter no later than fifteen
24	(15) days after the end of each month until the election is held. However,
25	for any month in which certain days of that month are included in a
26	preelection financial report required under subdivision (a)(2) of this
27	section, no monthly report for that month shall be due, but those days of
28	that month shall be carried forward and included in the final financial
29	report.
30	(2) Additionally, a preelection financial report shall be filed
31	no less than seven (7) days prior to any election on the ballot question or
32	legislative question, such statement to have a closing date of ten (10) days
33	prior to the election.
34	(3) Furthermore, a final financial report shall be filed no
35	later than thirty (30) days after the election.
36	(b) A local-option ballot question committee or individual person who

(ii) Direct mail;

1	files a late financial report shall be subject to a late filing fee not to
2	exceed fifty dollars (\$50.00) for each day the report remains unfiled.
3	
4	3-8-609. Public inspection — Record retention.
5	(a) All statements of organization and financial reports required by
6	this subchapter shall be open to public inspection at the office of the
7	Arkansas Ethics Commission during regular office hours.
8	(b) All records supporting the reports filed under this subchapter
9	shall be:
10	(1) Made available to the commission; and
11	(2) Retained by the filer for a period of four (4) years after
12	the date of filing the report.
13	
14	3-8-610. Enforcement.
15	The Arkansas Ethics Commission shall have the same power and authority
16	to enforce the provisions of this subchapter as are provided the commission
17	under §§ 7-6-217 and 7-6-218 for the enforcement of campaign finance laws.
18	
19	3-8-611. Reporting the use of state funds to oppose or support a
20	ballot measure.
21	Any funds appropriated to any state agency, board, or commission that
22	are expended, as prescribed in § 7-9-413, for the purpose of opposing or
23	supporting a local-option ballot question that is submitted or intended to be
24	submitted to a popular vote at an election, whether or not it qualifies for
25	the ballot, shall be reported to the Legislative Council if the amount
26	exceeds one hundred dollars (\$100).
27	
28	3-8-612. Use of state funds to oppose or support a local-option ballot
29	measure.
30	The use of state funds under this subchapter includes expenditures for:
31	(1) Newspaper, television, radio, and other forms of
32	communication;
33	(2) Publication materials;
34	(3) Travel expenses relative to reimbursement;
35	(4) Surveys;
36	(5) Private contracts; and

1	(6) Postage.
2	
3	3-8-613. Applicability of §§ 3-8-611 and 3-8-612.
4	This act does not apply to state funds appropriated to any elected
5	officials.
6	
7	3-8-614. Scope.
8	Nothing in this subchapter may limit, waive, or abrogate the scope of
9	any statutory or common law privilege, including, but not limited to, the
10	work product doctrine and the attorney-client privilege.
11	
12	3-8-615. Penalty.
13	Upon conviction, any person who knowingly fails to comply with this
14	subchapter shall be fined an amount not to exceed one thousand dollars
15	(\$1,000) or be imprisoned for not more than one (1) year, or both.

17	SECTION 8. Arkansas Code Title 3, Chapter 8, is amended to add an
18	additional subchapter to read as follows:
19	<u>Subchapter 7 — Paid Canvassers</u>
20	
21	3-8-701. Definitions.
22	As used in this subchapter:
23	(1) "Canvasser" means a person who circulates a local option
24	election petition or a part or parts of a local option election petition to
25	obtain the signatures of petitioners thereto;
26	(2) "Paid canvasser" means a person who is paid or with whom
27	there is an agreement to pay money or anything of value before or after a
28	signature on a local option election petition is solicited in exchange for
29	soliciting or obtaining a signature on a petition;
30	(3) "Petitioner" means a person who signs a petition requesting
31	a local option election; and
32	(4) "Sponsor" means a person who arranges for the circulation of
33	a local option election petition or who files a local option election
34	petition with the official charged with verifying the signatures.
35	
36	3-8-702 Hiring and training of paid canvaccars

1	(a)(l) A person shall not provide money or anything of value to
2	another person for obtaining signatures on a local option election petition
3	unless the person receiving the money or item of value meets the requirements
4	of this section.
5	(2) Before a signature is solicited by a paid canvasser the
6	sponsor shall:
7	(A) Provide the paid canvasser with a copy of the most
8	recent edition of the Secretary of State's initiatives and referenda
9	handbook;
10	(B) Explain the Arkansas law applicable to obtaining
11	signatures on a local option election petition to the canvasser; and
12	(C)(i) Provide a complete list of all paid canvassers'
13	names and current residential addresses to the Secretary of State.
14	(ii) If additional paid canvassers agree to solicit
15	signatures on behalf of a sponsor after the complete list is provided, the
16	sponsor shall provide an updated list of all paid canvassers' names and
17	current residential addresses to the Secretary of State.
18	(b) Before obtaining a signature on a local option election petition
19	as a paid canvasser, a person shall submit in person or by mail to the
20	sponsor:
21	(1) The full name and any assumed name of the person;
22	(2) The current residence address of the person and the person's
23	permanent domicile address if the person's permanent domicile address is
24	different from the person's current residence address;
25	(3) A signed statement taken under oath or solemn affirmation
26	that states that the person has not pleaded guilty or nolo contendere to or
27	been found guilty of a criminal offense involving a violation of the election
28	laws, fraud, forgery, or identification theft in any state;
29	(4) A signed statement that the person has read and understands
30	the Arkansas law applicable to obtaining signatures on a local option
31	election petition;
32	(5) A signed statement that the person has been provided a copy
33	of the most recent edition of the Secretary of State's initiatives and
34	referenda handbook by the sponsor; and
35	(6) A photograph of the person taken within ninety (90) days of
36	the submission of the information required under this section.

1	(a) A grouper shall maintain the information required under this
1	(c) A sponsor shall maintain the information required under this
2	section for each paid canvasser for three (3) years after the general
3	<u>election.</u>
4	
5	SECTION 9. Arkansas Code Title 5, Chapter 55, is amended to create a
6	new subchapter to read as follows:
7	<u>Subchapter 6 - Election, Petition, and Ballot Fraud</u>
8	
9	5-55-601. Petition fraud.
10	(a) As used in this section, "petition" means a petition under § 3-8-
11	201 et seq., § 3-8-701 et seq., or § 7-9-101 et seq.
12	(b) A person commits the offense of petition fraud:
13	(1) If the person knowingly:
14	(A) Signs a name other than his or her name to a petition;
15	(B) Signs his or her name more than one (1) time to a
16	<u>petition; or</u>
17	(C) Signs a petition when he or she is not legally
18	entitled to sign the petition;
19	(2) If the person acting as a canvasser, notary, sponsor as
20	defined under § 7-9-101, or agent of a sponsor:
21	(A) Signs a name other than his or her own to a petition;
22	(B) Prints a name, address, or birth date other than his
23	or her own to a petition unless the signor requires assistance due to
24	disability and the person complies with § 7-9-103;
25	(C) Solicits or obtains a signature to a petition knowing
26	that the person signing is not qualified to sign the petition;
27	(D) Knowingly pays a person any form of compensation in
28	exchange for signing a petition as a petitioner;
29	(E) Accepts or pays money or anything of value for
30	obtaining signatures on a petition when the person acting as a canvasser,
31	sponsor, or agent of a sponsor knows that the person acting as a canvasser's
32	name or address is not included on the sponsor's list filed with the
33	Secretary of State under § 7-9-601; or
34	(F) Knowingly misrepresents the purpose and effect of the
35	petition or the measure affected for the purpose of causing a person to sign
36	a petition:

1	(3) If the person acting as a canvasser, knowingly makes a false
2	statement on a petition verification form;
3	(4) If the person acting as a notary, knowingly fails to witness
4	a canvasser's affidavit by witnessing the signing of the instrument in person
5	and either personally knowing the signor or by being presented with proof of
6	the identity of the signer; or
7	(5) If the person acting as a sponsor, files a petition or a
8	part of a petition with the official charged with verifying the signatures
9	knowing that the petition or part of the petition contains one (1) or more
10	false or fraudulent signatures unless each false or fraudulent signature is
11	clearly stricken by the sponsor before filing.
12	(c) Petition fraud is a Class A misdemeanor.
13	
14	SECTION 10. Arkansas Code § 7-9-103(b), concerning certain criminal
15	offenses regarding petitions, is repealed.
16	(b) A person shall be deemed guilty of a Class A misdemeanor if the
17	person:
18	(1) Signs any name other than his or her own to any petition;
19	(2) Knowingly signs his or her name more than once to any
20	petition;
21	(3) Knowingly signs a petition when he or she is not legally
22	entitled to sign it;
23	(4) Knowingly and falsely misrepresents the purpose and effect
24	of the petition or the measure affected for the purpose of causing anyone to
25	sign a petition;
26	(5) Acting in the capacity of canvasser, knowingly makes a false
27	statement on a petition verification form; or
28	(6) Acting in the capacity of a notary, knowingly fails to
29	witness a canvasser's affidavit either by witnessing the signing of the
30	instrument and personally knowing the signer or by being presented with proof
31	of identity of the signer.
